## Speakers

**Kimberly Augenstein, MD**, is board certified in pediatrics, physical medicine and rehabilitation, and pediatric rehabilitation medicine. She completed her postgraduate education and training at the University of Michigan, while also earning her certification in secondary education. This, in addition to parenting four adoptive and foster daughters with unique learning needs, has placed her in a position to understand the roles of school, community and medical rehabilitation for children and adolescents with disabilities. Dr. Augenstein practices in Traverse City. As the only pediatric rehabilitation physician in northern Michigan, she serves a diverse adult and pediatric population.

**Erica Austin, DO**, completed medical school, her neurology residency and her neurophysiology fellowship through the Michigan State University College of Osteopathic Medicine. She served as faculty in the Department of Neurology prior to moving to Traverse City to open a private practice neurology clinic in 2016. Dr. Austin serves as a Professional Adviser for the Michigan Epilepsy Foundation and is board certified by the American Board of Psychiatry and Neurology in Neurology, Neurophysiology, and Epilepsy. She treats patients with all types of neurological disorders, with a particular emphasis on epilepsy.

**Randall Benson, MD**, completed medical school through the Hahnemann University in Philadelphia, Penn., and his fellowship in Behavioral Neurology and Functional Neuroimaging through Massachusetts General Hospital in Boston, Mass. He is a globally-regarded behavioral neurologist and imaging neuroscientist recognized for developing new treatments for incapacitating brain disorders through the use of advanced, functional Magnetic Resonance Imaging (fMRI) methods. He became the first dual Research Fellow in Behavioral Neurology and fMRI at Harvard Medical School and the NMR Center at Massachusetts General Hospital. Dr. Benson pioneered a new technique, fMRI, for mapping language areas in the brains of neurosurgical patients. This led to FDA approval for "fMRI pre-surgical mapping" in 2007 and it now is a globally-practiced clinical procedure. Dr. Benson's commitment to finding novel ways to enhance recovery of function after stroke led to multiple investigations into the use of targeted electrical/magnetic stimulation of the brain in motor and language impairment following stroke.

**Andrew Cole MD**, joined Mary Free Bed in May 2017. He provides physiatry services for Mary Free Bed Network partner outpatient sites, primarily through Munson Medical Center in Traverse City. Dr. Cole is a board-certified brain injury specialist. He is sub-specialized in neurological rehabilitation with other areas of focus, including musculoskeletal conditions and pain management. Dr. Cole is a graduate of the University Of Utah School Of Medicine and completed his residency in physical medicine and rehabilitation there.

**Daniel Eaton, RN, CBIS**, earned his Associate in Applied Science-Nursing from Schoolcraft College in 2008. He is a registered nurse and Certified Brain Injury Specialist as well as Michigan State Director for NeuroRestorative. He is an elected board member for the Michigan Brain Injury Provider Council (MBIPC), Chair of the MBIPC Government Relations Committee and a Certified Brain Injury Specialist-Proctor.

**Kelly Greene, PsyD, ABPP-CN**, earned her doctorate degree in clinical psychology from the Chicago School of Professional Psychology. She completed a two-year post-doctoral residency at Mary Free Bed Rehabilitation Hospital in 2002. She is board certified by the American Board of Professional Psychology in clinical neuropsychology and pediatric clinical neuropsychology. She currently is employed at the Aleda E. Lutz VA Medical Center Grand Traverse Clinic where she treats veterans and pediatric and adult Mary Free Bed Rehabilitation Hospital patients.

**Blake Ringsmuth** obtained his undergraduate and law degrees for the University of Michigan. Licensed in Michigan since 1990, he is an attorney practicing in the field of brain injury litigation and is partner at the Traverse City law firm Ringsmuth Wuori, PLLC. Mr. Ringsmuth has been active for several years in the Brain Injury Network of Northern Michigan.
